

Purposes (EAP) module, which provides essential language preparation for university study.
NCUK's EAP is equivalent to IELTS and is acceptable for visa requirements. The assessment breakdown is generally 25% coursework and 75% exam.

Entry Requirements


One of: - 48 points with 2 x D grades (NCUK International Foundation Year)

- 2 x D grades at A level
- Scored 24 points or more on the International Baccalaureate
- A GPA 2.0 first-year pass from a US degree

And: - IELTS 5.5 or equivalent *Full list of entry requirements can be found on NCUK's website.

*Some university degree courses may require an additional year of study.
